DETTITION

Construction Work

Any work carried out in connection with the construction, alteration, conversion, fitting-out, commissioning, renovation, repair, maintenance, refurbishment, demolition, decommissioning or dismantling of a structure.

High Risk Construction Work

Means construction work that:

- (a) involves a risk of a person falling more than 2 metres; or
- (b) is carried out on a telecommunication tower; or
- (c) involves demolition of an element of a structure that is load-bearing or otherwise related to the physical integrity of the structure; or
- (d) involves, or is likely to involve, the disturbance of asbestos; or
- (e) involves structural alterations or repairs that require temporary support to prevent collapse; or
- (f) is carried out in or near a confined space; or
- (g) is carried out in or near:
 - (i) a shaft or trench with an excavated depth greater than 1.5 metres; or
 - (ii) a tunnel; or
- (h) involves the use of explosives; or
- (i) is carried out on or near pressurised gas distribution mains or piping; or
- (j) is carried out on or near chemical, fuel or refrigerant lines; or
- (k) is carried out on or near energised electrical installations or services; or
- (l) is carried out in an area that may have a contaminated or flammable atmosphere; or
- (m) involves tilt-up or precast concrete; or
- (n) is carried out on, in or adjacent to a road, railway, shipping lane or other traffic corridor that is in use by traffic other than pedestrians; or
- (o) is carried out in an area at a workplace in which there is any movement of powered mobile plant; or
- (p) is carried out in an area in which there are artificial extremes of temperature; or
- (q) is carried out in or near water or other liquid that involves a risk of drowning; or
- (r) involves diving work.

Notifiable Incident

In this Act, *notifiable incident* means:

- (a)the death of a person; or
- (b)a serious injury or illness of a person; or
- (c)a dangerous incident.

Dangerous incident

Consists of the following:

- the uncontrolled escape, spillage or leakage of a substance
- an uncontrolled implosion, explosion or fire
- an uncontrolled escape of gas, steam or a pressurised substance
- an electric shock
- the fall or release from height of any plant, substance or thing
- the collapse, overturning, failure or malfunction of, or damage to, plant that is required to be licensed or registered
- the collapse or partial collapse of a structure, including an excavation or of any shoring supporting an excavation
- the inrush of water, mud or gas into an underground excavation or tunnel
- the interruption of the main system of ventilation to an underground



excavation or tunnel, or

- other incidents as stated in the WHS Regulations.

Serious injury or illness of a person An injury or illness requiring the person to have:

- (a)immediate treatment as an in-patient in a hospital; or
- (b)immediate treatment for:
 - (i)the amputation of any part of his or her body; or
 - (ii)a serious head injury; or
 - (iii)a serious eye injury; or
 - (iv)a serious burn; or
 - (v)the separation of his or her skin from an underlying tissue (such as degloving or scalping); or
 - (vi)a spinal injury; or
 - (vii)the loss of a bodily function; or
 - (viii)serious lacerations; or
- (c)medical treatment within 48 hours of exposure to a substance,

and includes any other injury or illness prescribed by the regulations as set out below:

- (a) any infection to which the carrying out of work is a significant contributing factor, including any infection that is reliably attributable to carrying out work –
- (i) with micro-organisms; or
- (ii) that involves providing treatment or care to a person; or
- (iii) that involves contact with human blood or body substances; or
- (iv) that involves handling or contact with animals, animal hides, skins, wool or hair, animal carcasses or animal waste products;
- (b) the following occupational zoonoses contracted in the course of work involving handling or contact with animals, animal hides, skins, wool or hair, animal carcasses or animal waste products:
- (i) Q fever;
- (ii) Anthrax;
- (iii) Leptospirosis;
- (iv) Brucellosis;
- (v) Hendra Virus;
- (vi) Avian Influenza;
- (vii) Psittacosis.
